AWARENESS AND ASSUMPTION OF RISK

I am the Parent/Guardian of the minor(s) participating in the Rideau Roundtable's Rideau Experience canoeing activity ("Activity"). I understand that during participation of the minor(s) named below in this Activity, they may be exposed to a variety of hazards and risks, foreseen or unforeseen, which are inherent in this Activity. These inherent risks include, but are not limited to, the dangers of serious personal injury, property damage, and death ("Injuries and Damages") from exposure to the hazards of the Activity. The Rideau Roundtable has not tried to contradict or minimize my understanding of these risks. I know that these Injuries and Damages can occur by natural causes or activities of other persons, participants, animals, Activity members, Activity leaders, directors, officers, owners of the facilities where the activities occur, volunteers, and assistants or third parties, either as a result of negligence or because of other reasons.

I AM EXECUTING THIS WAIVER ON BEHALF OF THE MINOR(S) MENTIONED IN MY CAPACITY AS THE PARENT/GUARDIAN, AND MYSELF, TO FREELY ACCEPT AND FULLY ASSUME ALL RISKS AND THE POSSIBILITY OF PERSONAL INJURY, DEATH, PROPERTY DAMAGE, EXPENSE AND RELATED LOSS, INCLUDING LOSS OF INCOME.

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

In consideration of the Rideau Roundtable and Paddle Canada accepting my application to participate in this Activity, I agree:

1. TO WAIVE and DISCHARGE any and all CLAIMS that I or the Minor(s) have or may have in the future against the Rideau Roundtable & Paddle Canada, its officers, directors, employees, agents, and leaders from any and all liability on account of, or in any way resulting from Injuries and Damages connected with this Activity.
2. TO RELEASE the Rideau Roundtable and Paddle Canada from any and all liability for any injury, death, property damage, expense and related losses, including loss of income that I or the Minor(s) or our respective next of kin may suffer as a result of participation in this Activity.
3. TO HOLD HARMLESS AND INDEMNIFY the Rideau Roundtable and Paddle Canada from any and all liability for any damage to property of, or personal injury to, any third party, resulting from participation of the Minor(s) in this Activity.
4. TO GIVE MY PERMISSION for the free use of the name(s) of the minor(s) and image(s) in broadcast, telecast or other media account of the Activity and for the promotional purposes of Rideau Roundtable's Rideau Experience Program in Voyageur Canoeing.
5. That this Agreement is intended to be as broad and inclusive as is permitted by the laws of Canada and Ontario. If any provision or any part of any provision of this Agreement is held to be invalid or legally unenforceable for any reason, the remainder of this Agreement shall not be affected thereby and shall remain valid and fully enforceable.
6. That this agreement is binding on not only me, but my next of kin, heirs, executors, administrators, and assignees.

9. I and the minor(s) represent and warrant to the Releasees that the minor(s) have not been advised by the Government of Canada or Ontario Public Health or their doctor or the Ontario Ministry of Health website to self-isolate due to possible exposure to COVID-19.
10. I and the minor(s) are fully aware of the risks and hazards with respect to COVID-19 inherent in my participation in the tour.
11. I and the minor(s) freely and voluntarily agree to assume the risk with respect to COVID-19, including the risk of death, bodily injury or property damage, regardless of severity, that I (or my child/ward) may sustain as a result of my participation during the tours, howsoever arising, including, but not limited to, the active or passive negligence of the Releasees.

I HAVE READ THIS AGREEMENT AND UNDERSTAND IT. I AM AWARE THAT BY SIGNING THIS DOCUMENT I AM WAIVING CERTAIN RIGHTS WHICH I OR THE MINOR(S) OR RESPECTIVE NEXT OF KIN, HEIRS, EXECUTORS, ADMINISTRATORS, AND ASSIGNS MAY HAVE AGAINST THE RIDEAU ROUNDTABLE AND OTHERS.
